

How is 5G-ACIA structured?

5G-ACIA deliberations and decision-making activities take place at various levels:

Board

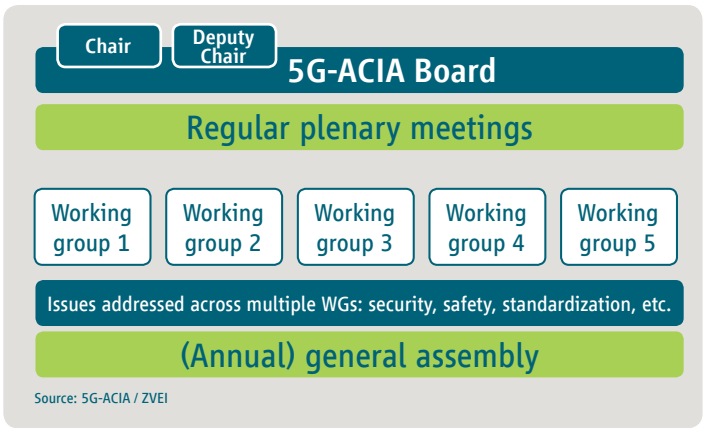
The 5G-ACIA Board comprises high-level representatives of our member organizations. They review 5G-ACIA's work strategy, settle disputes, and advise 5G-ACIA's organizational bodies. The Board meets on a regular basis.

General assembly

The 5G-ACIA general assembly meets once a year. Its responsibilities include electing the 5G-ACIA Chair, the 5G-ACIA Deputy Chair, the 5G-ACIA Board, and the Chairs of the working groups. In addition, it approves 5G-ACIA's budget

Plenary meetings

The 5G-ACIA plenary session is attended by representatives of our member organizations. It convenes every two to three months to review and evaluate ongoing work.

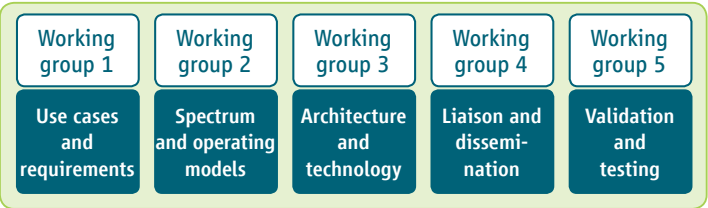

5G-ACIA's core activities are assigned to five working groups (WGs). Each WG consolidates its findings on a regular basis in the form of a 5G-ACIA white paper.

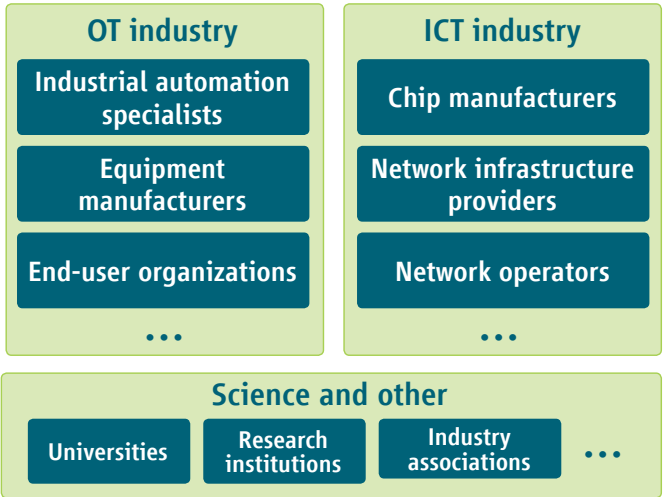

Who are the members?

5G-ACIA brings together a wide variety of 5G stakeholders. These are primarily organizations from the OT (operational technology) and ICT (information and communication technology) industries. Other members include educational and research institutions, and additional relevant groups.

What is the membership fee?

Annual fees are based on members' global revenues (related to the group, not to subsidiaries).

Category	Global annual revenues	Annual fee
1	up to 50 million euros	€5,000
2	50-500 million euros	€15,000
3	more than 500 million euros	€30,000

Members who join prior to July 1 pay the entire annual contribution. Those who join after this date pay half the annual contribution for that year. ZVEI members contribute €10,000 (€5,000 if their annual revenues are less than 50 million euros).

What is the relationship between 5G-ACIA and ZVEI?

Legally, ZVEI (the German Electrical and Electronic Manufacturers' Association) is the host organization for 5G-ACIA. It provides the infrastructure for global cooperation and supports pre-competitive exchange in compliance with EU legislation.
